Progress of Acquisition of Treasury Stock and End of Acquisition

Tokyo, August 5, 2024 ----- Wacom Co., Ltd. (the "Company") announces the progress of acquisition of its treasury stock pursuant to Article 156 of Japanese Companies Act, of which application is defined by both paragraph 1, Article 459 of the Companies Act and provisions of the Company's Articles of Incorporation, as follows.

As a result, the Company also announces that the acquisition pursuant to the resolution at the meeting of the Board of Directors held on May 9, 2024 has ended.

1. Details of acquisition completed

- (1) Type of shares acquired: Common stock of the Company
- (2) Total number of shares acquired: 300,100 shares
- (3) Total acquisition cost: 206,285,600 Japanese yen
- (4) Acquisition period: From August 1, 2024, to August 2, 2024 (on a trade basis)
- (5) Acquisition method: Open market acquisition of shares on the Tokyo Stock Exchange

- (1) Type of shares to be acquired: Common stock of the Company
- (2) Total number of shares to be acquired: Up to 6,000,000 shares
Equivalent to 4.13% of outstanding shares (excluding treasury stock)
- (3) Total acquisition cost: Up to 3.0 billion Japanese yen
- (4) Acquisition period: From May 10, 2024 to September 30, 2024
- (5) Acquisition method: Open market acquisition of shares on the Tokyo Stock Exchange

- (1) Total number of shares acquired: 4,032,500 shares
- (2) Total acquisition cost : 2,999,974,500 Japanese yen
