Progress of Acquisition of Treasury Stock

Tokyo, November 1, 2024 ----- Wacom Co., Ltd. (the “Company”) announces the progress of acquisition of its treasury stock pursuant to Article 156 of Japanese Companies Act, of which application is defined by both paragraph 1, Article 459 of the Companies Act and provisions of the Company’s Articles of Incorporation, as follows.

1. Details of acquisition completed

- (1) Type of shares acquired: Common stock of the Company
- (2) Total number of shares acquired: 228,100 shares
- (3) Total acquisition cost: 157,426,200 Japanese yen
- (4) Acquisition period: October 31, 2024 (on a trade basis)
- (5) Acquisition method: Open market acquisition of shares on the Tokyo Stock Exchange

- (1) Type of shares to be acquired: Common stock of the Company
- (2) Total number of shares to be acquired: Up to 4,000,000 shares
Equivalent to 2.83% of outstanding shares (excluding treasury stock)
- (3) Total acquisition cost: Up to 2.0 billion Japanese yen
- (4) Acquisition period: From October 31, 2024 to January 20, 2025
- (5) Acquisition method: Open market acquisition of shares on the Tokyo Stock Exchange

- (1) Total number of shares acquired: 228,100 shares
- (2) Total acquisition cost : 157,426,200 Japanese yen
