ASKUL Corporation (the "Company") announces the status of acquisition of treasury stock in accordance with the provisions of Article 156 of the Companies Act as applied by replacing terms pursuant to the provisions of Paragraph 3 of Article 165 of the Companies Act based on the resolution passed at the meeting of the Board of Directors held on September 13, 2024 as shown below.

The Company also announces that, with the following acquisition, it has completed the acquisition of treasury stock based on the resolution of the Board of Directors meeting held on September 13, 2024.
